1. ABX4 9, Chapter 9 Statutes of 2009 **4689 TBL Section 24: Supported Living Services**. The regional center shall not make rent, mortgage, or lease payments on a supported living home or pay for household expenses for more than six months, unless the regional center finds that it is necessary to meet the individual consumer's particular needs pursuant to the consumer's IPP.
2. California Code of Regulations Title 17 **§58611(b): Housing Financial Involvement and Responsibilities**. The regional center shall not pay any costs incurred by a consumer receiving SLS in securing, occupying, or maintaining a home rented, leased, or owned by the consumer except when the executive director of the regional center has determined (exception)
3. California Code of Regulations Title 17 **§58613 (B): Consumer Eligibility Determination**. Living in a home that is not the place of residence of a parent or conservator of the consumer.
4. California Code of Regulations Title 17 **§58613 (a) (2): Consumer Eligibility Determination**. Has expressed directly or through the consumer's personal advocate, as appropriate, a preference for: (A) SLS among the options proposed during the IPPP process...
5. **WIC 4689 (8)** Consumers shall not be excluded from supported living arrangements based solely on the nature and severity of their disabilities

(a) Personal Support Service. ... to meet the consumer's need for assistance with common daily living and routine household activities, accessing medical services... Personal Support must be tailored to meet those specific needs of an individual consumer ... in that the immediate results of the service (e.g. successful preparation of a meal) is the primary objective of the service. (b) Training and Habilitation Service. ... is intended to result in an increased ability on the part of the consumer to establish and maintain constructive human relationships, ... and meet his/her needs without assistance... accessed only when any corresponding Personal Support Service alternative is determined to be less appropriate. Training and Habilitation differs from any corresponding Personal Support Service in that the immediate results of the service is... consequential to, but never the primary objective of the training.
